Marianne - introduction of Fulmont Action Agency, no longer able to be housed at Warren Street School (GJSD), need two classrooms, think they'd be a perfect fit

Marianne - specific regulations to work with children (not daycare), federally funded "headstart program" to prepare for school

GJSD-specific program, currently not at full enrollment (16), can serve 32 children 3-5yo, M-F Sept-Jun semi-flexible hours, no provided transportation, have liability insurance, will install cameras

Building fits ADA requirements, needs maintenance and confirmation of other federal requirements, needs "climbing apparatus" (next to church on Clinton Street), contracts would need escape clauses on both ends (just in case) Marianne and Michelle departed at 19:25

Look into fees, Fulmont as renters could assist with building expenses, need to get rid of asbestos, new boiler?, our expenses will go up to meet many of their regulations

General conclusion: worth crunching the numbers and legalese
